THE FOREST ACT

THE FOREST (COCOA WALK 1, ST. CATHERINE FOREST MANAGEMENT
AREA) (DECLARATION) ORDER, 2025

In exercise of the power conferred upon the Minister by section 7(1)(a) of the Forest Act, and of every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the Forest (Cocoa Walk 1, St. Catherine Forest Management Area) (Declaration) Order, 2025.

2. The areas described in Part I of the Schedule, and delineated on the maps set out in Part II thereof, is declared a forest management area and shall be known as the Cocoa Walk 1, St. Catherine Forest Management Area.

SCHEDULE

(Paragraph 2)

PART—I

Cocoa Walk 1, St. Catherine Forest Management Area

The Cocoa Walk 1, St. Catherine Forest Management Area is described as follows—

Block A

All that parcel of Crown Land situated in the parish of St. Catherine and containing by estimation 24 acres or 9.712 hectares and being part of Cocoa Walk Land Settlement and numbered as Lot 119 on the Cocoa Walk Land Settlement Plan and registered at Volume 1053 Folio 853 with Land Valuation Number 16904017030, and butting and bounded as follows—

- Northerly — on Lot 118 of said plan and on remainder of Cocoa Walk with Land Valuation Numbers 16904005006 and on 16904005026,
- Easterly — on land with Land Valuation Number 16904005023, Lots 120 and 121 of said Plan,
- Southerly — on reserved road,
- Westerly — on reserved road,

or however otherwise the same land may be butted, bounded, known or otherwise described.

Block B

All that parcel of Crown Land situated in the parish of St. Catherine and containing by estimation 43 acres or 17.402 hectares and being part of Cocoa Walk Land Settlement and numbered as Lot 150 on the Cocoa Walk Land Settlement Plan and registered with Land Valuation Number 16904020001, and butting and bounded as follows—

- Northerly — on reserved road, and lot 146 registered at Volume 1053 Folio 853 with Valuation Number 16904020004,
- Easterly — on remainder of Cocoa Walk, registered at Volume 1025 Folio 512,
- Southerly — on reserved road,
- Westerly — on reserved road,

or however otherwise the same land may be butted, bounded, known, distinguished, or otherwise described.
