THE FOREST ACT

THE FOREST (KENILWORTH, HANOVER FOREST MANAGEMENT AREA)
(DECLARATION) ORDER, 2025

In exercise of the power conferred upon the Minister by section 7(1)(a) of the Forest Act, and of every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the Forest (Kenilworth, Hanover Forest Management Area) (Declaration) Order, 2025.

2. The area described in Part I of the Schedule, and delineated on the map set out in Part II thereof, is declared a forest management area and shall be known as the Kenilworth, Hanover Forest Management Area.

SCHEDULE

(Paragraph 2)

PART—I

Kenilworth, Hanover Forest Management Area

The Kenilworth, Hanover Forest Management Area is described as follows—

All that piece or parcel of Crown Land ground-truthed as Kenilworth, situated in the parish of Hanover containing by estimation 202.6785 hectares, being part of title registered at Volume 1080 Folio 178, in the name of the Commissioner of Lands, butting and bounding as follows—

- Northerly — on the same lands known as Kenilworth registered at Volume 1080 Folio 178 owned by the Commissioner of Lands, Volume 1177 Folio 618 owned by Aston Stewart, Volume 1383 Folio 272 owned by the Commissioner of Lands, Volume 1081 Folio 521 owned by James Stewart, lands with Land Valuation Number 02102003001 owned by Mary Bowen, and on lands with Land Valuation number 02102005001 owned by Mulveina Hall,
- Easterly — on lands with Land Valuation Number 02102009008 owned by Ernest Grant, Land Valuation Number 02102008003 owned by James Smith, Land Valuation Number 02102008004 owned by Beatrice Bright, Land Valuation Number 02102008005 owned by Ethilda Ellis, Volume 1388 Folio 379 owned by Albert Walker, Land Valuation Number 02102008007 owned by Clifford Jarrett, Land Valuation Number 02102008008 owned by Daniel Ellis Estate, on lands part of Volume 1080 Folio 178 owned by the Commissioner of Lands, and reserved road from Cascade to Kew Bridge to Great River Main Road,
- Southerly — on the same lands, registered at Volume 1080 Folio 178 owned by the Commissioner of Lands,
- Westerly — on the same lands, registered at Volume 1080 Folio 178 owned by the Commissioner of Lands and reserved road leading to Kew Bridge to Great River Main Road,

or however otherwise the same land may be butted, bounded, known, distinguished, or otherwise described.
