

# THE FOREST ACT

## **The Forest (Intention to Declare as Forest Reserve) (Millbank Forest Estate) (Block 1 and Block 2) Notice, 2026**

---

In exercise of the power conferred upon the Minister by section 10(1) of the Forest Act, and of every other power hereunto enabling, the following Notice is made:-

1. This Notice may be cited as the Forest (Intention to Declare as Forest Reserve) (Millbank Forest Estate) (Block 1 and Block 2) Notice, 2026.
2. The Minister hereby gives notice of the Minister's intention to declare by order under section 5, the following areas described and delineated in Parts I and II of the Schedule, to be a forest reserve.
3. Members of the public may, if they so desire, provide written comments to the Minister in relation to the proposed order, within ninety days from the date of publication of this Notice. Comments may be submitted to –

#### **Block 1**

All that parcel of Crown Land known as Millbank, comprising Block 1 of Millbank Forest Estate, situated in the parish of Portland, containing by survey 12.1693 hectares and registered at Volume 1175 Folio 815 in the name of the Commissioner of Lands, butting and bounding as follows –

***Northerly*** on lands known as Millbank, registered at Volume 57 Folio 81, owned by Charles Osbourne, and on

lands registered at Volume 53 Folio 92, owned by Jane Massy;

***Easterly*** on lands known as Fish Brook, registered at Volume 1171 Folio 257, owned by the Commissioner of Lands;

***Southerly*** on lands known as Bowden Pen, registered at Volume 1162 Folio 54, owned by the Commissioner of Lands;

***Westerly*** on lands being part of Millbank, registered at Volume 220 Folio 92, owned by the Commissioner of Lands, registered at Volume 72 Folio 111, owned by Naseef Abdullah, and registered at Volume 68 Folio 16, owned by Charles Osbourne, or however otherwise the same may be butted, bounded, known, distinguished or described.

**Block 2**

All that parcel of Crown Land known as Millbank, comprising Block 2 of Millbank Forest Estate, situated in the parish of Portland, containing by survey 8.2301 hectares and registered at Volume 220 Folio 92 in the name of the Commissioner of Lands, butting and bounding as follows –

***Northerly*** on lands known as Millbank, registered at Volume 48 Folio 75, owned by J.C. Hayden, registered at Volume 68 Folio 16, owned by Chas Osbourne, and registered at Volume 72 Folio 111, owned by Naseef Abdullah;

***Easterly*** on lands known as Millbank, registered at Volume 1175 Folio 815, owned by the Commissioner of Lands;

***Southerly*** on lands known as Bowden Pen, registered at Volume 1162 Folio 54, owned by the Commissioner of Lands;

*Westerly* on the Blue Mountain Forest Reserve – Rio Grande Block, Western (District 22),

or however otherwise the same may be butted, bounded, known, distinguished or described.
