

THE FOREST ACT

The Forest (Intention to Declare as Forest Reserve) (Montpelier Forest Estate) (Block 1 and Block 2) Notice, 2026

In exercise of the power conferred upon the Minister by section 10(1) of the Forest Act, and of every other power hereunto enabling, the following Notice is hereby made: –

1. This Notice may be cited as the Forest (Intention to Declare as Forest Reserve) (Montpelier Forest Estate) (Block 1 and Block 2) Notice, 2026.
2. The Minister hereby gives notice of the Minister’s intention to declare by order under section 5, the following areas described and delineated in Parts I and II of the Schedule, to be a forest reserve.
3. Members of the public may, if they so desire, provide written comments to the Minister, in relation to the proposed order, within ninety days from the date of publication of this Notice. Comments may be submitted to –

Northerly on reserved road leading to the Anchovy-Montpelier Main Road;

Easterly on lands registered at Volume 1198 Folio 47, owned by the Commissioner of Lands, with Land Valuation Number 032B4Y02001;

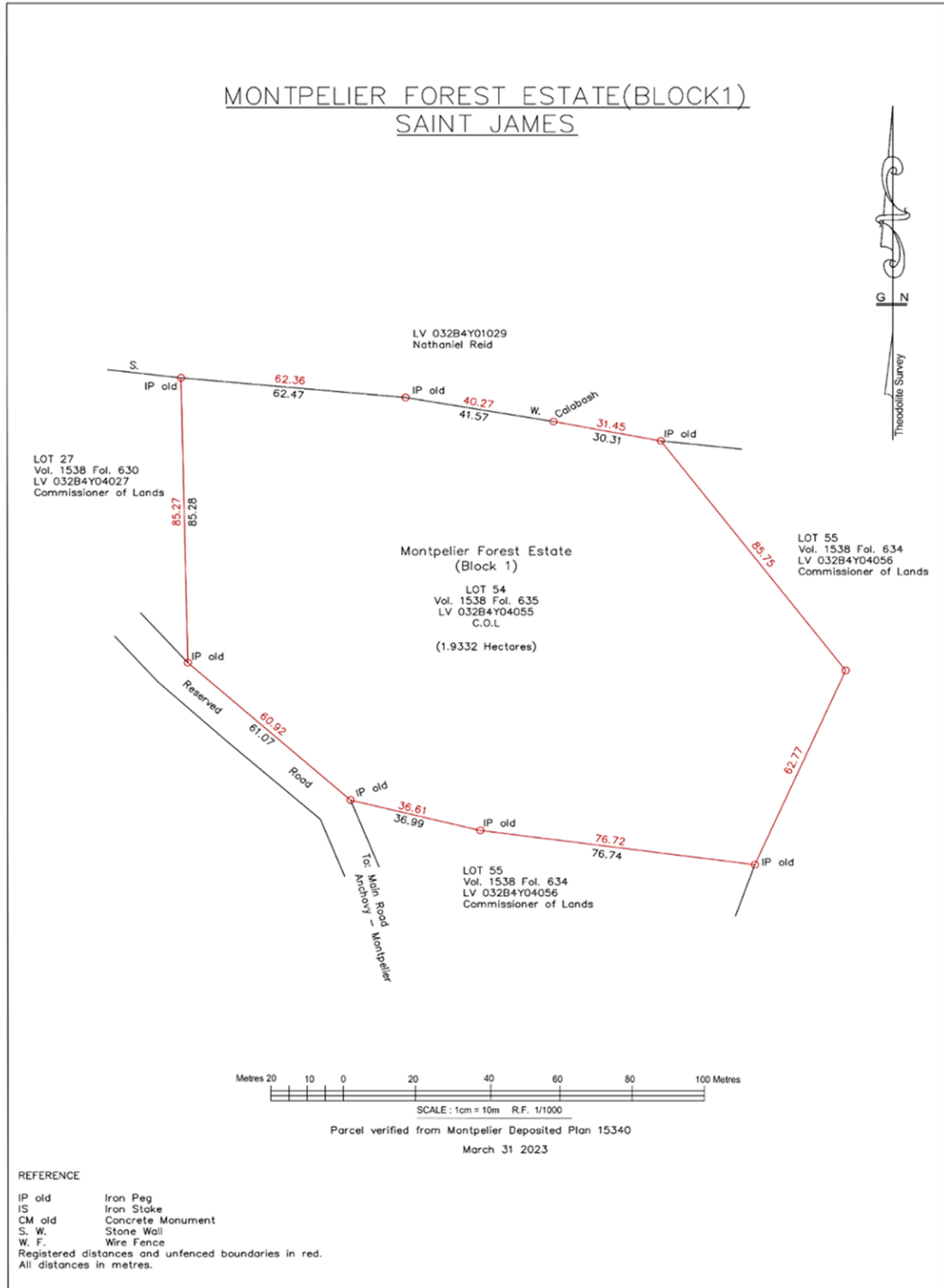
Southerly on lands registered at Volume 1433 Folio 215, owned by Montpelier Citrus Company Limited, with Land Valuation Number 032D2Z01014;

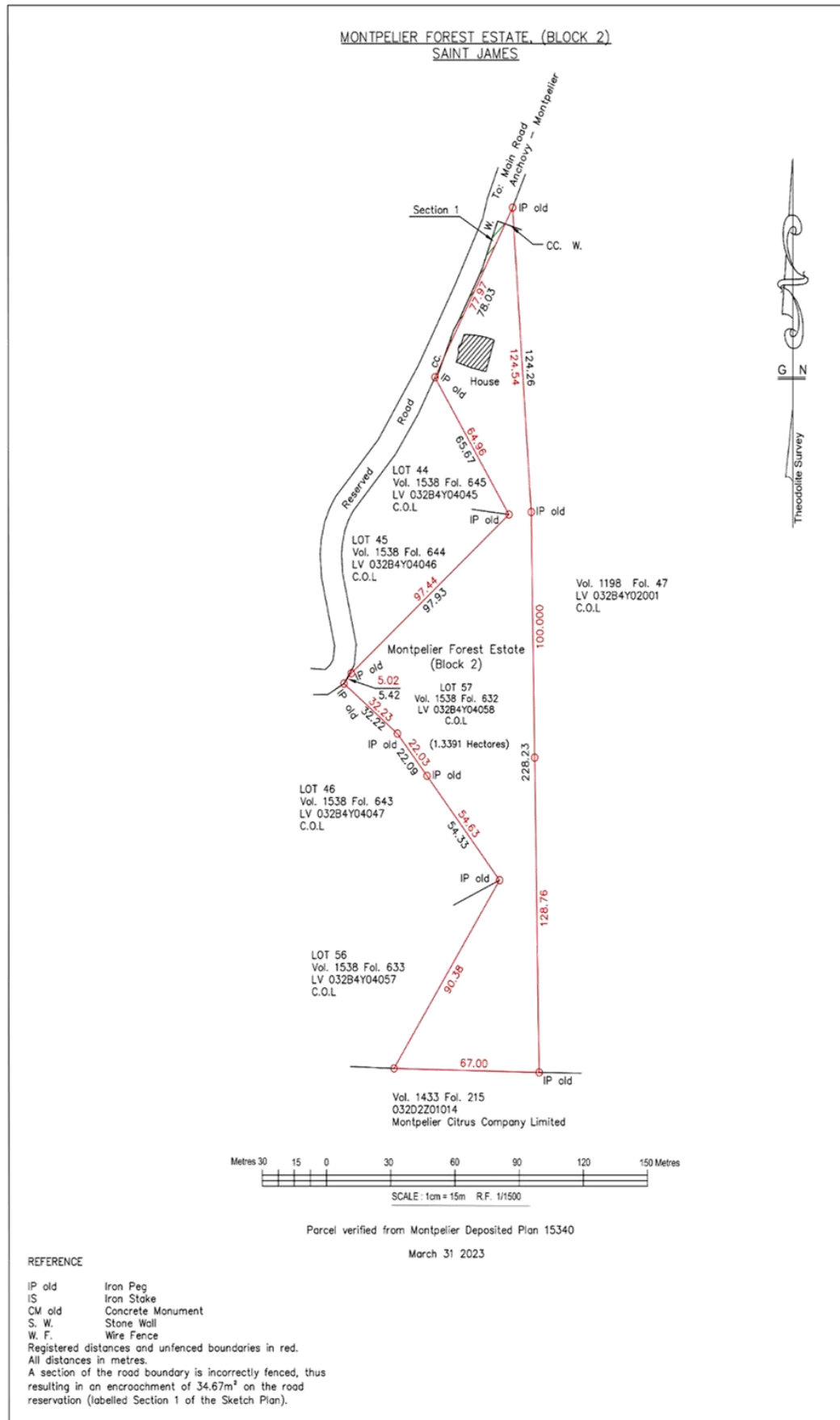
