**THE FOREST ACT**

THE FOREST (ROSE HALL, ST. ANN FOREST MANAGEMENT AREA)  
(DECLARATION) ORDER, 2025

In exercise of the power conferred upon the Minister by section 7(1)(a) of the Forest Act, and of every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the Forest (Rose Hall, St. Ann Forest Management Area) (Declaration) Order, 2025.

2. The area described in Part I of the Schedule, and delineated on the map set out in Part II thereof, is declared a forest management area and shall be known as the Rose Hall, St. Ann Forest Management Area.

## SCHEDULE

## PART—I

*Rose Hall, St. Ann Forest Management Area*

The Rose Hall, St. Ann Forest Management Area is described as follows—

All that parcel of Crown Land situated in the parish of St. Ann, containing approximately 5.6590 hectares, being part of lands registered at Volume 1357 Folio 157 with Land Valuation Number 06906007001 in the name of the Commissioner of Lands, butting and bounded as follows—

Northerly — on part of lands registered at Volume 1357 Folio 157 in the name of the Commissioner of Lands and being occupied by the Jamaica Defence Force with Land Valuation Number 06906007001,

Easterly — on lands registered at Volume 1357 Folio 157 in the name of the Commissioner of Lands with Land Valuation Number 06906007001, Lot 21 registered at Volume 1327 Folio 183 with Land Valuation Number 06906006005, Lot 222 registered at Volume 1327 Folio 274 with Land Valuation Number 06906006096, Lot 221 registered at Volume 1327 Folio 273 with Land Valuation Number 06906006095,

Southerly — on Lot 92 registered at Volume 1292 Folio 256 with Land Valuation Number 06906005030, Lot 93 registered at Volume 1292 Folio 257 with Land Valuation Number 06906005031, Lot 94 registered at Volume 1292 Folio 258 with Land Valuation Number 06906005032, Lot 95 registered at Volume 1292 Folio 259 with Land Valuation Number 06906005033, Lot 96 registered at Volume 1292 Folio 260 with Land Valuation Number 06906005034, Lot 97 registered at Volume 1292 Folio 261 with Land Valuation Number 06906005035. 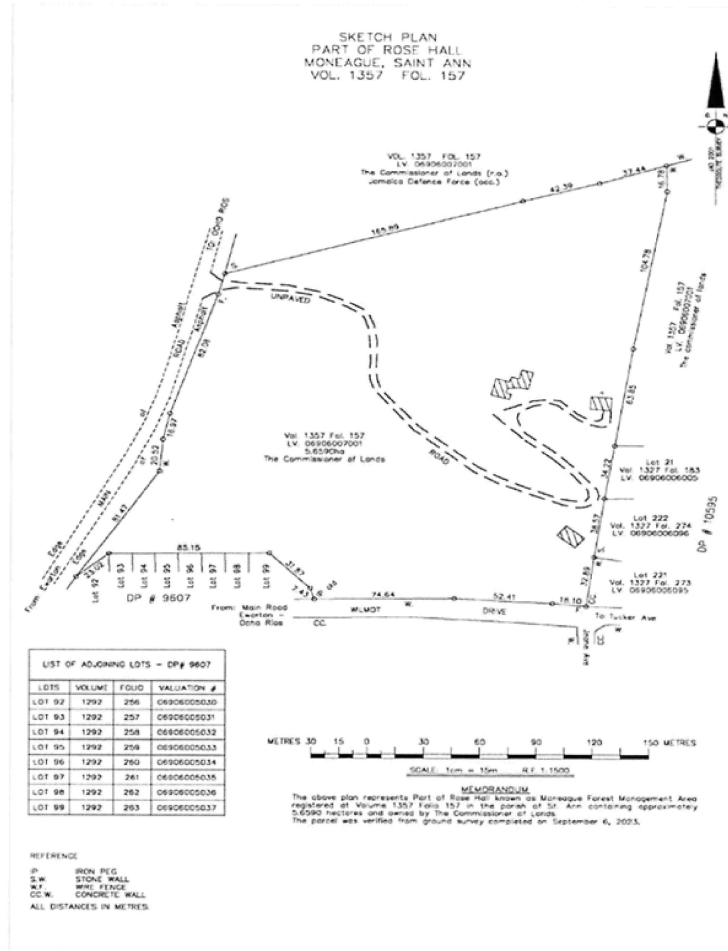
*Westerly* — on Main Road from Ewarton to Ocho Rios,
