THE FOREST ACT

THE FOREST (SCHWALLENBURGH, ST. ANN FOREST MANAGEMENT AREA)
(DECLARATION) ORDER, 2025

In exercise of the power conferred upon the Minister by section 7(1)(a) of the Forest Act, and of every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the Forest (Schwallenburgh, St. Ann Forest Management Area) (Declaration) Order, 2025.

2. The area described in Part I of the Schedule, and delineated on the map set out in Part II thereof, is declared a forest management area and shall be known as the Schwallenburgh, St. Ann Forest Management Area.

SCHEDULE

(Paragraph 2)

PART—I

Schwallenburgh, St. Ann Forest Management Area

The Schwallenburgh, St. Ann Forest Management Area is described as follows—

All that parcel of Crown Land situated in Schwallenburgh known as Section 5B in the parish of St. Ann and containing by survey 493.5845 hectares and registered at Volume 831 Folio 88 in the name of the Commissioner of Lands and recorded at Land Valuation Number 08806001003, butting and bounded as follows—

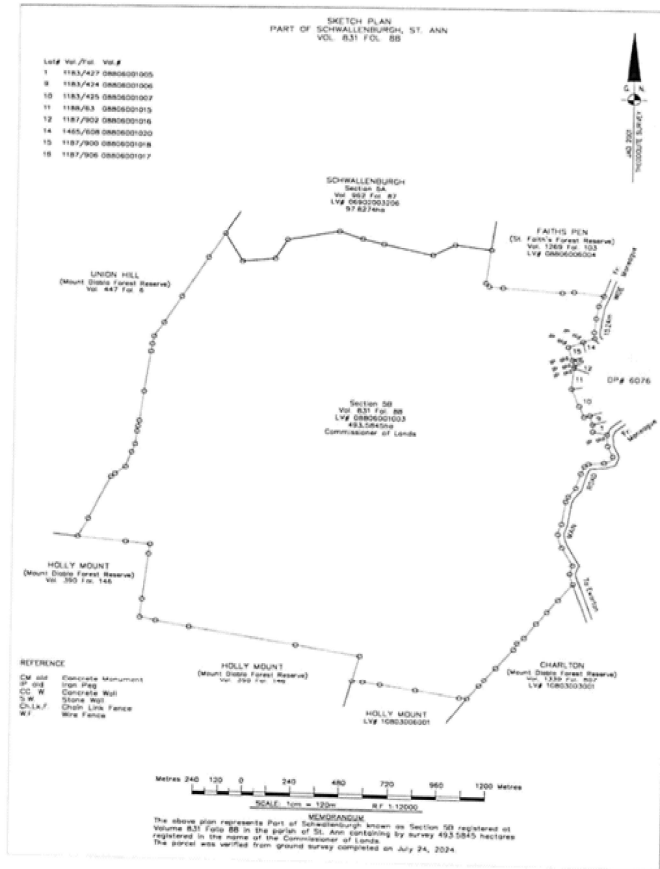
- Northerly — on part of Schwallenburgh known as Section 5A registered at Volume 962 Folio 87 with Land Valuation Number 06902003206, on part of Faiths Pen known as St. Faith's Forest Reserve registered at Volume 1269 Folio 103 with Land Valuation Number 08806006004,
- Easterly — on the Moneague to Ewarton Main Road, on Lot 14 registered at Volume 1465 Folio 608 with Land Valuation Number 08806001020, Lot 15 registered at Volume 1187 Folio 900 with Land Valuation Number 08806001018, Lot 16 registered at Volume 1187 Folio 906 with Land Valuation Number 08806001017, Lot 12 registered at Volume 1187 Folio 902 with Land Valuation Number 08806001016, Lot 11 registered at Volume 1188 Folio 63 with Land Valuation Number 08806001015, Lot 10 registered at Volume 1183 Folio 425 with Land Valuation Number 08806001007, Lot 9 registered at Volume 1183 Folio 424 with Land Valuation Number 08806001006, Lot 1 registered at Volume 1183 Folio 427 with Land Valuation Number 08806001005, on the Moneague to Ewarton Main Road, on part of Charlton known as Mount Diablo Forest Reserve registered at Volume 1339 Folio 807 with Land Valuation Number 10803003001,
