THE FOREST ACT

THE FOREST (COCOA WALK 2, ST. THOMAS FOREST MANAGEMENT AREA)
(DECLARATION) ORDER, 2025

In exercise of the power conferred upon the Minister by section 7(1)(a) of the Forest Act, and of every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the Forest (Cocoa Walk 2, St. Thomas Forest Management Area) (Declaration) Order, 2025.

2. The areas described in Part I of the Schedule, and delineated on the map set out in Part II thereof, is declared a forest management area and shall be known as the Cocoa Walk 2, St. Thomas Forest Management Area.

SCHEDULE

(Paragraph 2)

PART—I

Cocoa Walk 2, St. Thomas Forest Management Area

The Cocoa Walk 2, St. Thomas Forest Management Area is described as follows—

All that parcel of Crown land being part of Cocoa Walk numbered as A, B, C and D recorded at Land Valuation Number 19405013087, 19405013088, 19405013090, and 19405013089 respectively, of Cocoa Walk Land Settlement situated in the parish of St. Thomas and totaling by survey 56.304 hectares and butting and bounding as follows—

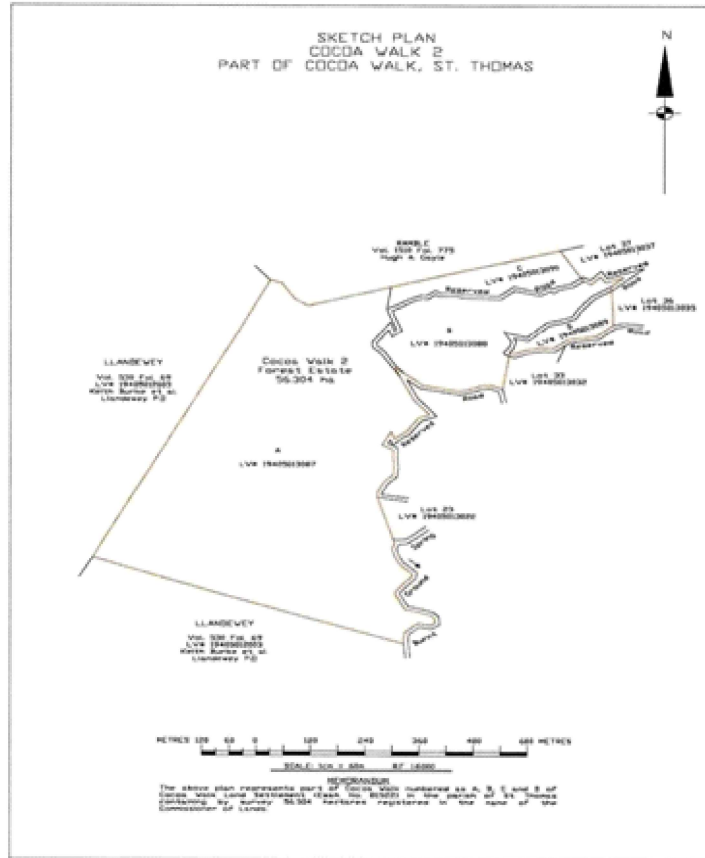
- Northerly — on Ramble registered at Volume 1510 Folio 775 in possession of Hugh A. Gayle,
- Easterly — on Lot 37 recorded at Land Valuation Number 19405013037, Reserved Road, Lot 36 recorded at Land Valuation Number 19405013035, Reserved Road, Lot 33 recorded at Land Valuation Number 19405013032, Reserved Road, Lot 23 recorded at Land Valuation Number 19405013022, and on Burnt Ground Spring,
- Southerly — on Llandewey registered at Volume 530 Folio 69 and recorded at Land Valuation Number 19405012003 in possession of Keith Burke *et al*,
- Westerly — on Llandewey registered at Volume 530 Folio 69 and recorded at Land Valuation Number 19405012003 in possession of Keith Burke *et al*,

or however otherwise the same land may be butted, bounded, known, distinguished, or otherwise described.
